### Request for Nominations

  3. Group (school, business, civic group, congregation, team, etc.)
- **July 30, 2021 is the deadline for nominations.**

- The selection committee is comprised of Catholic Charities West Virginia board members, staff and advisory council members who will select the honorees.
- ***Please let the person(s) you are nominating know of your plans to nominate them and ensure they are available to attend the Awards Luncheon on Friday, October 22, 2021.*** The Luncheon begins at 11:30 a.m. in Charleston.
- You will be notified if your nominee is selected.
- All selected honorees will be contacted and confirmed before being announced publicly.

### Nomination Criteria

1. Nominee shows exemplary effort in charitable activities that align with Catholic Charities' core values of charity, compassion, dignity, hope, justice, and quality.
2. Nominee's charitable activities support Catholic Charities West Virginia either directly with the agency as supporter/volunteer or in collaboration/partnership.
3. Some of nominee's charitable action must be visible in the boundaries of the Catholic Charities West Virginia Western Region (Charleston, Huntington, Parkersburg and surrounding communities).
4. Nominee must be available to attend the Awards Luncheon on October 22, 2021, and must be willing to be interviewed for media promotion.

### Nomination Process

1. CCWVa announces application with submission deadline.
2. Applications are reviewed by the Western Region Director for criteria confirmation.
3. Applications are sent to the Advancement Committee of the Board of Directors for vote.
4. Top 3 nominees are sent to the President and Chief Executive Officer who notifies honorees and confirms their attendance at the October 22 Luncheon.
